REPORT REGARDING THE SITUATION OF THE SPONSORSHIPS GRANTED BY CONPET S.A. IN THE YEAR 2019

The sponsorship activity carried out by CONPET S.A. is performed according to the provisions of Law no. 32/1994 regarding sponsorship, further ammendments and completions, of Order no. 994/1994 on the approval of instructions for applying Law no. 32/1994 regarding sponsorship, of Law 227/2015 regarding the Fiscal Code, further ammendments and completions, EGO no. 127/1999 regarding the establishment of tax measures and improvement of achievement and collection of state revenues, of Law no. 576/2001 for approval of EGO 127/1999, of Order no. 2634/2015 issued by the Ministry of Finances on November 5th, 2015, regarding the financial accounting documents, of EGO no. 2/2015 regarding the modification and completion of some normative acts, as well as other measures, further ammendments and completions, respectively according to the Internal operational procedure "SPONSORSHIPS" - code PO – 10 – 04.

The sponsorship activities are carried out without exceeding the sponsorship expenses broken down by areas of interest, in accordance with the annual revenue and expenditure budget,

At the same time, we mention that the sponsorship requests are subject to the analysis approval of the Board of Administration, according to the Articles of Incorporation of CONPET S.A, para. 20 Powers of the Board of Administration, letter o) "approves the requests of sponsorship".

For year 2019, in the Income and Expenses Budget of CONPET S.A. were provided sponsorship expenses worth 705,000 RON.

Within the meetings of the Board of Administration of CONPET SA were approved, in the period 01.01-31.12.2019, sponsorships worth 684,077.74 RON, as follows:
