The financial investment company **SIF BANAT-CRIȘANA S.A.**, based in Arad, No. 35A Calea Victoriei St., registered at the Trade Registry Office attached to Arad Law Court under no. Considering the EGMS Convening Notice convened on 28.04.2022 - the first call / 29.04.2022 – in second call, published in OGR (Official Gazette of Romania) Part IV no. 1206 / 23.03.2022, the provisions of art. 16 para. (6) of the Articles of Incorporation of CONPET S.A.,

As a shareholder of CONPET SA, with **a holding of 562,740 shares representing 6.5%** of the share capital,

Pursuant to art. 117¹ para. (1) of Law no. 31/1990, art. 105 para. (3) of Law no. 24/2017 regarding the issuers of financial instruments and market operations and of art. 189 of ASF Regulation no. 5/2018, according to which one or more shareholders, representing individually or together at least 5% of the share capital of the company, may request the company's Board of Directors to introduce additional items on the agenda of the GMS,

formulates the following:

**REQUEST
TO COMPLETE THE AGENDA OF THE EXTRAORDINARY GENERAL MEETING
OF SHAREHOLDERS
CONVENED ON 28/29 APRIL 2022**

By which we request the introduction of the following 2 (two) new items on the agenda of the Extraordinary General Meeting of Shareholders, convened on April 28/29, 2022:

1. Approval of the amendment to the Articles of Incorporation of the Company “CONPET” S.A., according to the proposals in the Annex to the Convocation of the EGMS Convening Notice (Draft amendment to the Articles of Incorporation).

2. Empowerment:

a) To the chairman of the EGMS to sign the updated version of the Articles of Incorporation, following the approved amendments.

b) To the Director General to perform all due diligence necessary to submit / register the updated version of the Articles of Incorporation at the Trade Registry Office attached to the Prahova Law Court, to publish in the Official Gazette of Romania Part IV, as well as to grant the right to delegate the proxy to another person, to carry out the above-mentioned diligence.

Justification for the introduction of new items on the agenda of the Ordinary General Meeting:

1. Justification for the first proposed item:

Considering the Letter of Expectations from the majority shareholder, the Romanian State, through the Ministry of Energy, which was elaborated in accordance with GEO no.109/2011, with the amendments and additions via Law no. 111/2016 and in accordance with the provisions of the Methodological Norms for the application of the GEO no. 109/2011, with subsequent amendments and additions, approved by GD no. 722/2016, which expresses the desideratum of the tutelary public authority and of CONPET SA’s shareholders regarding the position and evolution of the company, the Board of Directors, elected according to the provisions of the GEO no. 109/2011, appointed via the OGMS no. 5/22.08.2018 resolution, elaborated the Management Plan, summarized to the shareholders in the 18.12.2018 meeting, along with the administrators’ KPI.

Considering the Strategic Objectives for the 2018-2022 period, established and undertaken by the administrative management within the administrative component, defined in close correlation with the strategic directions, the vision and expectations of the tutelary authority, namely those of the shareholders and the contextual line of the Romanian’s Energy Strategy for the 2018-2030 period, with the perspective of the 2050s:

- I. Business activity increase and enhancement of the activity performance**
- II. Development of new activities related and non-related to core business**
- III. Defining the company as a regional player**
- IV. Efficient management of human resources**
- V. Implementation and development of the corporate governance principles**

In the Strategic Objective no. 2 of the Management Plan, namely Development of new activities related and non-related to the core business, the Measure no. 2.4 refers to the production of electricity from renewable sources.

Through the modernization and systematization programs of the pumping stations in CONPET SA's working points, significant land areas are being made available, so there is the possibility of obtaining suitable locations for the installation of solar panels, namely land areas for the location of wind installations.

On March 30, 2022, the Ministry of Energy announced the inauguration of the projects program for the production of energy from renewable sources (wind and solar), with a budget of 457,700,000 euros, funded via the P.N.R.R. Applications can be submitted between March 31, 2022 – May 31, 2022.

The State aid scheme based on the competitive bidding procedure is also addressed to large enterprises, whose main or secondary activity, included in the statute of the company, encompasses the production of electricity (**for the purpose of selling it and / or for consumption within the company or group of companies**), corresponding to division 35: “the production and supply of electricity and heat, gas, hot water and air conditioning”, NACE class 3511 - Production of electricity and which have submitted to the Ministry of Energy the tender within the competitive bidding procedure for the granting of state aid, before the commencement of the works.

2. Justification for the second proposed item:

In order to carry out the resolutions regarding the amendment of CONPET's Articles of Incorporation, it is necessary that the Extraordinary General Meeting of Shareholders approve the empowerment of the Chairman of the Board of Directors to update and sign the company's updated version of the Articles of Incorporation, brought about by the changes of the EGMS resolution, in order to carry out the legal advertising formalities.

Also, in order to implement the resolutions approved by the Extraordinary General Meeting of Shareholders, it is necessary to approve the Director General's empowerment to carry out all due diligence necessary to register the EGMS resolutions and the updated Articles of Incorporation at the Trade Register Office attached to Prahova Law Court, publish in the Official Gazette of Romania, Part IV, as well as to grant the right to delegate the proxy to carry out the previously mentioned formalities.
