**Reporting significant events:** as per Art. 99, lett. j) of the Bucharest Stock Exchange (BVB) Code Book I - Title II Issuers and Financial Instruments - Summons drafted by OMV PETROM S.A. București.

CONPET S.A informs the shareholders and investors that on 12.09.2022, the Bucharest Court of Appeal has communicated the summons filed by OMV Petrom S.A. București in contradictory with the National Agency for Mineral Resources – (A.N.R.M.) and CONPET S.A. Ploiesti, by which the court, by the decision to be issued, is requested to rule:

- Cancellation in part of article 1 of A.N.R.M. Order 229/2021 regarding the tariffs set out in Annex 1 and Annex 3 and, accordingly, of Annexes 1 and 3 of Order 229/2021 and, as a consequence, ordering A.N.R.M. to issue a new order for the approval of the transport tariffs through the National Transport System of crude oil, rich gas, condensate and ethane for 2022, which would include tariffs modified accordingly in terms of DOMESTIC tariffs (Annex 1) and import tariffs for refineries in the Ploiesti Basin (Annex 3).
- The annulment in part of art. 3-8 of the Annex to A.N.R.M. Order no. 53/2008, as well as the obligation of A.N.R.M. to issue a new order which should properly supplement Order no. 53/2008.
- Order the respondent to pay the court costs.

We hereby mention that the summons is subject to File no.5971/2/2022 and it has not yet court date. CONPET SA shall proceed to carry out all procedural endeavors required in this case.
