**Reporting significant events:** as per Art. 99 lett j) of the Bucharest Stock Exchange (BVB) Code Book I - Title II Issuers and Financial Instruments - Summons drafted by OMV PETROM S.A. București.

CONPET S.A informs the shareholders and investors that on 13.10.2022, the Bucharest Court of Appeal has communicated the summons filed by OMV Petrom S.A. București in contradictory with the National Agency for Mineral Resources – ( Ro. A.N.R.M.) and CONPET S.A. Ploiesti, by which the court, by the decision to be issued, is requested to rule:

- Cancellation in part of the Contract Addendums no. 2-9 to the transport contract no. BC OMV 108/25.03.2020 concluded between OMV Petrom and CONPET, namely of the articles regarding the tariffs of the DOMESTIC and IMPORT subsystems charged for the transport services provided by CONPET and established via the NAMR Order 229/2021, within the limit of the amount of the tariffs that will be established following the administrative litigation proceedings carried out by OMV Petrom regarding the tariffs with NAMR and, as a consequence, the obligation of CONPET to pay compensations to OMV Petrom representing the difference between the amount of the tariffs adopted via NAMR Order no. 229/2021, paid by OMV Petrom in the period 01.01.2022-31.08.2022 and the amount of tariffs that will be established in file no. 5971/2/2022, updated with the inflation index, as well as the related legal interest
- Payment to OMV Petrom of the difference between the amount of tariffs paid by OMV Petrom for the transport of marine crude oil, through the DOMESTIC subsystem, from the Midia Terminal, and the amount of tariffs through the IMPORT subsystem depending on the subsystem actually used, updated with the inflation index, as well as the corresponding legal interest.
- Obligation of CONPET to pay any sums representing civil fruits that CONPET acquired or could have acquired in relation to the amounts charged from OMV Petrom based on the tariffs.
- Obligation to pay the court costs.

We hereby mention that the summons is subject to File no. 7035/2/2022 and it still has no court date. CONPET S.A. shall proceed to carrying out all the procedural endeavors required in this case.
